### WHY THESE INFORMATION

### COOKIE RULES

The site [www.bedandbreakfastnuovafieradiroma.it](http://www.bedandbreakfastnuovafieradiroma.it) does not store data of its users but uses only technical and analytical

cookies (not profiling related to marketing actions) because it uses the Google Analytics tool. Below is the privacy statement of Google Analytics.

### Data provided by the user voluntarily
